INFORMATION

The State's Attorney of said county charges:

COUNT I

That on 1st day of September, 2024, in Monroe County, TREVOR M STAWIZYNSKI, committed the offense of AGG DUI/ACCIDENT/DEATH in that the said defendant knowingly and unlawfully while under the influence of alcohol, drove a 2013 Nissan Altima upon a roadway in violation of 625 ILCS 5/11-501(a)(1), and while committing said violation, was involved in a motor vehicle crash resulting in the death of C.B., in violation of 625 ILCS 5/11-501(a). Class 2 Felony.

A non-probationable felony, that in the event the defendant is convicted, the defendant shall be sentenced to a term of imprisonment of not less than 3 years and not more than 14 years in the Illinois Department of Corrections, or Juvenile Justice Center.

COUNT II

That on 1st day of September, 2024, in Monroe County, TREVOR M STAWIZYNSKI, committed the offense of AGG DUI/ACCIDENT/BODILY HARM in that the said defendant knowingly and unlawfully while under the influence of alcohol, drove a 2013 Nissan Altima upon a roadway, in violation of 625 ILCS 5/11-501(a)(1), and while committing said violation, was involved in a motor vehicle crash resulting in great bodily harm to J.N., in violation of 625 ILCS 5/11-501(d)(1)(c), in violation of 625 ILCS 5/11-501(a). Class 4 Felony.

A non-probationable felony, that in the event the defendant is convicted, the defendant shall be sentenced to a term of imprisonment of not less than 1 year and not more than 12 years in the Illinois Department of Corrections, or Juvenile Justice Center.

COUNT III

That on 1st day of September, 2024, in Monroe County, TREVOR M STAWIZYNSKI, committed the offense of RECKLESS HOMICIDE/MTR VEHICLE in that the said defendant knowingly and unlawfully while acting in a reckless manner, performed acts likely to cause the death of or great bodily harm to another, in that he operated a 2013 Nissan Altima in a westerly direction along and upon Hanover Road in Monroe County, Illinois at a time when he was under the influence of alcohol and was operating said vehicle at excessively dangerous speed, and that he skidded from the roadway and collided with a tree on the driver's side of the 2013 Nissan Altima, causing his 2013 Nissan Altima to break apart and eject C.B. from the Nissan Altima, thereby causing the death of C.B., in violation of 720 ILCS 5/9-3(a). Class 3 Felony.
